## NOTICE TO PROSPECTIVE PHARMACY TECHNICIAN STUDENTS

Remington College is accredited by the Accrediting Commission of Career Schools and Colleges (ACCSC). The pharmacy technician program conducted by Remington College in Shreveport, LA is accredited by the American Society of Health System Pharmacists ("ASHP") and the Accreditation Council for Pharmacy Education.

- (b) The purpose of the training program;

- (f) Prospects for employment;
- (g) Realistic salary expectations or referral to local, state, or national statistics for salary expectations;
- (h) Total program cost;
- (i) The program's dismissal policy including academic and non-academic criteria, including, but not limited to, the organization's student code of conduct; and
- (j) Graduate performance on national exams.

The current qualifications to enroll, purpose of the training program, programmatic and institutional accreditation status, and dismissal policy including academic and non-academic criteria, including, but not limited to, the organization's student code of conduct are published in the College Catalog, which was provided to you during the admissions process. The total program cost is published in the Addendum to the College Catalog, which was also provided to you during the admissions process, and is stated on the Application and Enrollment Agreement that you will sign prior to enrollment. Graduates of the pharmacy technician program may be eligible to seek two national pharmacy technician certifications: (1) The Pharmacy Technician Certification Board (PTCB) Certified Pharmacy Technician (CPhT) Certification and (2) the National Healthcareer Association (NHA) Certified Pharmacy Technician (CPhT) Certification.

One of the requirements for obtaining the PTCB CPhT Certification is a passing score on the PTCB Pharmacy Technician Certification Exam (PTCE).
